

District 6 Annual General Meeting April 23, 2022

Held at Immanuel Christian Reformed Church, Hamilton

Hosted by Stoney Creek Garden Club: assisted by Mount Hamilton Horticultural Society.

Amended May 10 2022

Present: 97 members 20 of 21 societies represented. See attendance list and attendance list by society - Addendum 1.

1. Judy Wrobel, Stoney Creek President welcomed all District 6 members to the 2022 Annual General meeting and read out the land acknowledgement. Judy shared some house-keeping details and explained how the silent auction would work.

Kathy Spiwak, Past President of the Mount Hamilton Horticultural Society, extended a welcome and invited members to attend the 2022 District 6 Fall Breakfast meeting, Sept. 24, hosted by the Mount Hamilton Horticultural Society.

2. The business meeting was declared open by Catherine McGill, District 6 Director at 9:00 am. Catherine introduced Ontario Horticultural Association (OHA) Past President Katherine Smyth.

Katherine Smyth brought greetings from OHA President Charles Freeman. Katherine invited all members to attend the 2023 OHA convention to be held in Ottawa July 15-17, 2023. She commented on the 2021 convention held on Zoom and noted that Covid had provided an opportunity for all horticulture societies and garden clubs to advance their use and understanding of on-line technology. She commented on the impact of the “Not-for Profit” legislation and the still pending legalities decision from OMAFRA. There will be a three-year time-period for societies to adhere to the new legislation. Katherine noted that:

- OMAFRA awarded grants in 2021 without the need for a financial report,
- TPOB banking would continue to be used by OMAFRA for reporting
- the impact of Covid on OHA membership resulted in a loss of 5000 members (23%) and noted that membership is now increasing again
- OHA Conventions 2023 - Ottawa, 2024 - Guelph
- Year of the Garden: Katherine encouraged all societies to plant red, choose a garden hero, and make 2022 special in some way,
- Gardenontario is now trademarked for OHA use, and
- Societies should continue to use OHA door hangers, Gardenontario tools and promotional materials.

Katherine thanked Catherine McGill for her five years on the OHA Board; for her friendship and her unique ability to keep the work of the Board moving along and making it fun for all.

3. Marie Decker asked if there were any corrections or additions to the April 24, 2021 AGM minutes. One name spelling correction was noted and Marie moved the minutes be adopted as amended, seconded by Lil Taggart (Georgetown). Carried.

4(a) Financial Reports

The financial report was presented by Bob Heil who noted that the last two years during Covid had presented with very little financial activity. Moved by Bob Heil, seconded by Jane Leonard (Georgetown) that the Report of the Treasurer including the presentation of the Financial Examiners' Report and Financial Statements for the fiscal period ending December 31, 2021 be received, and that the Financial Statements as presented by the Treasurer and as reviewed by the Financial Examiners be the same and are hereby approved. Carried

Moved by Bob Heil, seconded by Mary Cameron (Burlington) that Jane Leonard and Doris Calder be appointed Financial Examiners of the 2022 District 6 Financial Records. Carried.

4(b) OHA District 6 Budget 2022

Bob Heil presented and answered questions on a proposed 2022 District 6 budget based on both normal District function and the possibility of unusual Covid restrictions.

District 6 acquired 319 new members over the past year. All societies increased their membership somewhat with the exception of five societies that stayed the same and two that decreased.

As an incentive to increase club membership Catherine announced a District plan to credit each society with a fifty cent decrease on their annual District membership dues for every new per new member signed up. This does not include renewing members, only new members.

Catherine announced that the September 24, 2022 District 6 Fall Breakfast meeting would require as many District 6 society Board members attending as possible as this meeting will be devoted to a workshop on increasing membership and getting members working together in more productive ways.

At the fall meeting, there will be workshops after lunch that will be for presidents, treasurers, secretaries and board members, everyone is welcome but those will be the groups we target for the talks.

Addendum 1 Report of the Treasurer and Financial Review Certificate REPORT

SUBJECT: 2021 Financial Review Report and Statements

The 2021 budget planned revenue of \$1,422.00 and expenses of \$1,422.00 for a balanced budget. I am pleased to report that the fiscal period ending December 31, 2021, reports a minor surplus of \$276.72 due in large part to a fund raising venture with the sale of tenna tops. Without the fundraising project, the District would have realized a deficit of approximately \$860. The Income Statement attached illustrates the actuals compared to the initial budget established by the Executive and Board.

The budget was a best guess due to the influence and effect of Covid-19. As everyone knows, "in-person" meetings were not permitted which resulted in reduced efforts for fund raising except for the tenna tops venture. The bright side is that the cost of operating District 6 was also reduced with virtual meetings being held with the District Director, the Assistant District Directors and each of the 21 Horticultural Societies in the District.

Due to the efforts of the District Director negotiating and obtaining several boxes of "tenna tops", District 6 was able to sell some of the boxes for a revenue of \$1,135. Membership dues collected from all 21 Societies equaled \$1,057.00 at \$0.50 per member. We also changed financial institutions from TD to First Ontario Credit Union and District 6 actually earned \$80.57 in investment and bank interest.

Our total Revenue in 2021 is \$2,272.57.

We migrated the financial reporting tools to QuickBooks in 2021 for better financial management. Costs for the District for 2021 were primarily mileage (\$827.64) and computer Zoom (\$229.68). The Executive and Board rented storage space in Burlington for District paraphernalia which cost \$353.35 for October to December. Other expenses for 2021 included guest speakers (\$246.18), fundraising (bee tattoos \$134.92), and postage, paper, envelopes and ink. (\$204.08)

Our total Expense for 2021 is \$1,995.85.

On behalf of the Executive and Board of the Ontario Horticultural Association District 6, I thank the Financial Examiners, Lee Vanspronsen and Trudy Bliedung of the Flamborough Horticultural Society. They took the time to examine the entries and provide a report to the District and its Societies that the books and records of the District fairly represent the financial transactions and financial position of the OHA District 6 at December 31, 2021. Their report and

all original entries will be filed with the Ontario Horticultural Association in accordance with Ontario Horticultural Association By-law Subsection 13.7.

The Report of the Financial Examiners and year end statements are attached to this Report and are distributed to all Affiliated Societies/Clubs to be shared with their members.

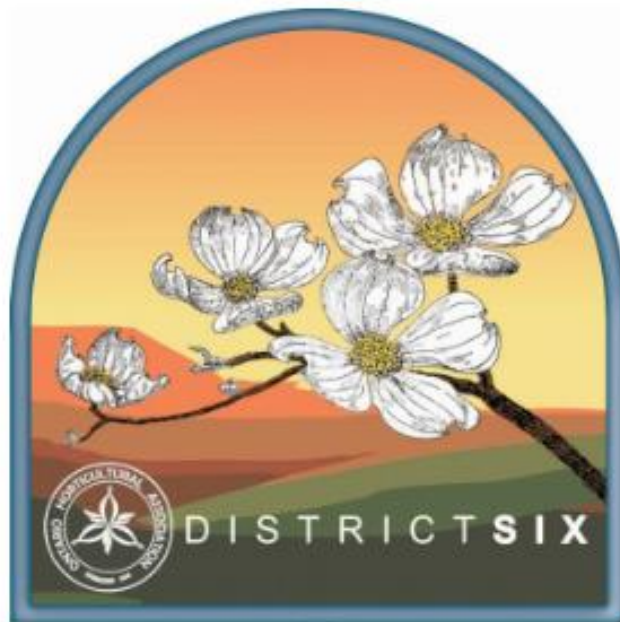

DATE: Annual General Meeting, April 23, 2022.

This report is filed with the AGM to illustrate the 2022 budget approved by the Executive on November 14, 2021. The Budget detail for the AGM has been finalized (Covid created uncertainty for the "in-person" vs "virtual" meeting) and the budget attached provides for the more detailed budget approved February 2022. Moreover, the budget for the storage unit was based on 12 payments of \$111.10 but the contract provides for \$111.10 every four weeks for 13 payments. The attached budget reflects the revised storage from \$1,333.20 to \$1,443.40.

Total revenue expected is \$9,093.00 and expenses are estimated to be \$12,790.40. Of course, all of this is subject to whatever Covid-19 dishes out.

As can be seen, there is an expected loss of \$3,697.40. If the actuals for 2022 match the budget, the end result will be a reduction of the Equity from current \$13,692.52 to \$9,995.12. This deficit can be managed by the District; however, in future, the Executive will need to consider fundraising ideas.
