Grab your hat and your coat, hop in the car and head to our national capital for the 100th anniversary convention of the Ontario Horticultural Association, to be held August 11th, 12th, and 13th, 2006. The convention hotel is the Crowne Plaza at 101 Lyons Street in the heart of Ottawa.

Don't be disappointed! Register early and come enjoy our city. We will dazzle you with our tours of Rideau Hall, the Byward Market, the world famous Experimental Farm, the Rideau Canal, the Herb Farm, as well as a number of private gardens.

Sit in the air-conditioned hall and listen to one of our seminar presenters. Our list includes Brian Carson, speaking on plants that can be deadly, Mark Dallas on hardy roses, Marc Ladouceur on sub-tropical gardening, Suzanne Patry on perennials, Joanne Plummer on design, Phillip Fry on habitat gardening, Paul Pospisil on garlic, and the Ottawa Valley Rock Gardening gurus demonstrating hypertufa containers.

We have rounded up a very impressive list of special speakers at the plenary sessions including CBC Radio guru Ed Lawrence, Mary Pratte, President of the Canadian Peony Society, Andre Poliquin, a microbiologist and specialist on clematis, and Alexander Reford, director of the Reford Gardens (les jardins du Metis).

We will have special presentations to Societies who also are 100 years old or older, but you will have to come to see who they are. A Match Made in Heaven

A signing ceremony held on March 29th to formalize a new relationship between the University of Guelph and Royal Botanical Gardens (RBG) means new research opportunities and an enhanced exchange of information between the two.

"The University and RBG both have a wealth of knowledge in the fields of horticulture and biodiversity and offer programming and education that is complementary." Issues to be explored under the partnership include the possibility of collaborative research and the promotion of the importance of horticulture and plants in fostering healthy urban environments, protection and rehabilitation of natural areas, academic opportunities for students and developing new sites for plant trials and testing.

Over the past five decades, Royal Botanical Gardens has become a centre of excellence in both horticulture and management of natural areas. Its 2,300 acres of nature sanctuaries contain many important habitats and one of the most significant and best-studied regional floras in Ontario. A herbarium houses some 80,000 specimens of wild plants and horticultural varieties and supports the institution's research activities and education programs. The five major garden areas covering more than 300 acres include domestic and international collections of cultivated plants.

The RBG's library and archives have provided research support to staff and visiting researchers and contain many rare and precious documents, including historical collections of seed trade catalogues, information related to the gardening and horticulture industry and the papers of several renowned horticulturists and botanists.

University of Guelph is internationally recognized for its teaching and research in biodiversity and is home to the Biodiversity Institute of Ontario, a unit that brings together many biological collections and research activities. Guelph is involved in research in floristics, molecular taxonomy and invasive species and boasts the Ontario Agricultural College Herbarium, a facility that houses more than 120,000 specimens. The University's library and 165-hectare Arboretum also promote and support history, education and exploration of knowledge related to biodiversity and horticulture.

Plant a Tree!


As the OHA celebrates its 100th year in gardening, we can use this as an opportunity to look back and plan ahead at the same time.

14th Annual Successful Gardening Show OHA Flower Show Report

Mississauga, ON, March 19th, 2006 – The show committee, exhibitors and volunteers were thrilled with this year’s show. The show management and publicists felt the same way. Our theme was “Ontario Horticultural Association, Celebrating 100 Years”.

The design classes included “Then and Now” a duo design (two sided); “Newsletter”, a black and white design; “Banquet” an exhibition segment table setting; “Agriculture”, a design using fruits and /or vegetables; “Balancing the Budget”, a design using two containers; “Memories” a design; and “Seeds” a miniature design, a) fresh, and b) dried.

A new class this year was the Judge’s Invitational Design, 5 entries only, titled “The Future”. The space allowed was 4’ x 4’ x 6’ tall. This class was a showstopper!

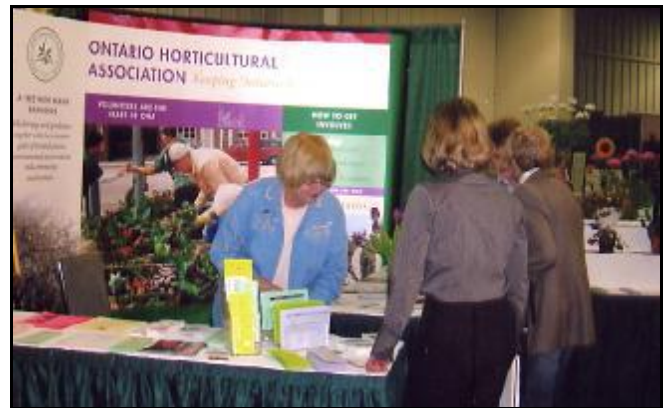
Show details were as follows:

Fort Malden Horticultural Society

Celebrating 100 Years of Gardening in Amherstburg
1906 - 2006



In a letter to the editor of the *Amherstburg Echo* on April 27, 1906, Dr. Oscar Teeter (Mayor 1901 and 1905) proposed that a horticultural society be formed in Amherstburg as "there are throughout the town innumerable plots of ground...which could be vastly improved by making them into nice lawns or flower gardens..." A meeting was scheduled for May 1, 1906, at which Dr. Teeter outlined the purposes of such an organization: improving the appearance of the town, purchasing bulbs and seeds at wholesale rates, and increasing the "enjoyment of life" of Amherstburg's citizens.

By the 1930s, the Amherstburg Horticultural Society had a membership of over 300. The first flower show was held in August, 1931 and was a huge success. The following year, according to records in the *Amherstburg Echo*, the Society was responsible for town beautification. The newspaper reported that the Society had planted a thousand trees on vacant lots on Alma Street, as well as flowerbeds at the Fort Malden Gas Station, Town Hall, Amherstburg Public School, and the library.

Like many other organizations, the Horticultural Society went into a state of remission during the years of World War II but was revived in 1954 as the *Fort Malden Horticultural Society*. The new Society carried on the tradition of planting flowering crabapple trees and shrubs along Laird Ave. Also, due to

redevelopment of the Navy Yard Park, a 90-foot quarry stone planter was removed. With the help of Mr. Murray Smith of Amherst Quarries and the efforts of fellow members, a planter was built and planted with prize-winning roses and flowering shrubs. Sadly, it was removed in the 1980s to make room for a parking lot for the King's Navy Yard Park.

The Rhododendron Gardens were developed under the guidance of "Rhodo Bob" Sutherland in 1984, located in the King's Navy Yard Park. With Bob's leadership, the famous Amherstburg Garden Tour was developed in 1986. In 2000, he was instrumental in adding a Garden Fair to this special weekend in May, which now attracts thousands of visitors to Amherstburg!

In recent years, the Society has established the Carol & Frank Gorham Student Scholarship, Trillium Awards, Parks Committee representation, Deck-the-Planters (a hanging basket program), a library garden, the reforestation of Laird Avenue Blvd, and other projects too numerous to fit in this space.

In November 2005, the Public Works Department planted 100 trees (donated by the Society) in Larry Bauer Park, Purdy Park, and Golfview Park in recognition of the Society's 100th Anniversary.

Who Do I Call? OMAFRA? OHA?

I find that horticultural society members are often confused about who to ask to find the information they need. Some questions are ones that should be directed to the Ontario Horticultural Association (OHA) and others need to be directed to the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA). The purpose of this article to help describe the role of OMAFRA and the questions that should be directed to the Ministry.

All horticultural societies in Ontario are incorporated under the Agricultural and Horticultural Organizations Act that is administered by OMAFRA. Under this Act, Societies file information annually to maintain incorporation, and are also eligible to receive grants for their activities. OMAFRA distributed over \$309,000 in grants for 2005. If you have questions related to your incorporation, proving your incorporation, your grant, or the OMAFRA forms that are filed by February 1st each year, direct these queries to OMAFRA.

If your society wants to change its name, dissolve (cease to exist) or a new society wishes to form then OMAFRA should be contacted as there are procedures that must be followed. Sometimes you need a "Letter of Good Standing" to prove your incorporation and OMAFRA is the one that issues it. Horticultural societies are not issued corporate numbers as some other not for profit organizations are and sometimes OMAFRA staff need to explain the legislation to others.

OMAFRA also has a role in helping organizations be more effective by developing resources, conducting workshops and giving consulting advice. Many times we find that people do not read the information that is sent by OHA or OMAFRA. Anything to do with your district, dues, volunteer hours, insurance, tulip fund, convention, fund raising, website, and competitions, is the responsibility of OHA and your district director or secretary can be of help with these. The OHA secretary Bonnie and I do talk and trade emails so your questions do not get lost. Hopefully this article gives you some idea where to get the information you need.

Restricted Funds - Restricted funds are funds tied to a specific use and not available for the general purposes of the organization (e.g., a fund consisting of contributions that donors specifically direct the registered charity to use to buy a new building). Endowments are one type of restricted fund. Donors create them when they stipulate that the registered charity must maintain the principal amount and only use the interest earned on it.

(The above was taken from the Canada Revenue Agency website regarding Registered Charities)

STBI - These funds are for the society treasurer bonding program and cannot be used for anything other than insurance payouts.

Bryan/Lobban/Bray Trust - Funds donated by past Presidents for the purposes of providing a special annual award for Youth.

The Memorial Fund - is money donated for names to be entered in the Memorial Book. This is for tree planting and societies can apply for \$100 towards planting a tree in memory of a member, family member, or friend.

The Tulip Fund - These funds were set aside to cover 5 x \$500 "grants" per year, for 5 societies to obtain plant material to be used in community projects. It was not for hardwoods or benches, only plant material.

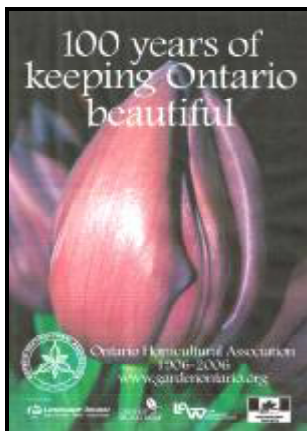

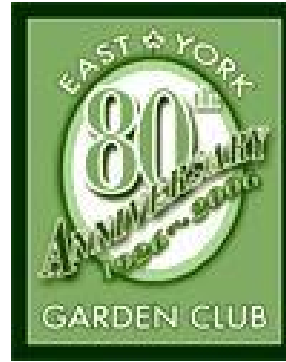
OHA 100th Anniversary Poster

Frequently Asked Questions

When in doubt, please consult the Society's OHA Manual, Section 5 on Meetings.

What is an Annual General Meeting and why is it important to have one?

It is most important to provide an opportunity for members of a Society to review the actions of the Board (Executive) during a twelve-month period. The Annual General Meeting (AGM) provides that opportunity. The Board (Executive) should report on what has transpired during the year. The report must include an audited financial report as well as reports on activities and accomplishments, etc. The members have an opportunity to praise or criticize the actions. The members also have the opportunity to elect the Officers and Directors for the coming year, after which they are officially installed. The AGM also provides the opportunity to amend the Constitution, By-Laws, etc. providing the members are informed in advance.

How is the slate of officers and directors announced to the membership and can others be nominated?

A Nominating Committee should provide a slate of Officers and Directors. It is most important, at the AGM, that a call for other nominations is made. Finally, if there are no other nominations, it is appropriate for the Chair to ask for a motion to accept the proposed slate as provided. A seconder is required, and the motion voted on.

When should the Society elect its Officers and Directors?

A society should elect its Officers and Directors at the AGM; this is also the time when the Officers and Directors are installed (usually by a member of the District Executive).

What constitutes an audited financial report and when is it required?

A financial report should be printed and made available to the membership at its AGM. It should include an auditor's signed statement indicating that the Treasurer's financial statements reflect the correct financial status of the Society. See OMAFRA fact sheet -- *Financial Policies and Procedures: Protecting Your Organization's Financial Assets (01-047)*.

When is a motion needed and what is the proper way of handling a motion?

A motion is needed whenever a group of members, society, or Board, is making important decisions. The motion provides a focus for discussion. The Chair should never make a motion, but should ask for a mover of a motion; the motion requires a seconder before discussion takes place. If there is no seconder, the motion 'dies'. It is important that time be given for adequate discussion before calling for the vote.

Are we an incorporated society? Are we a non-profit or charitable organization?

All horticultural societies are incorporated organizations under the Agricultural and Horticultural Organizations Act. In the case of societies in the Ontario Horticultural Association (OHA), there is the unique situation where the society must first apply to the Ontario Ministry for Agriculture, Food, and Rural Affairs (OMAFRA) for recognition as a duly constituted society. If approved, the society is duly incorporated under the Act. Accordingly, every society must operate as a non-profit organization without share capital, under the terms of reference of the Provincial Act. Thus, the first responsibility of every society is to OMAFRA (and the terms of the Act), and secondarily to the OHA as a member.

Only those societies which apply for special charitable status with the Government of Canada, and who are given a charitable number are recognized as charitable institutions.

How should a Constitution and By-Laws be structured for a Society?

In general, the format of a Constitution and By-Laws of an organization should follow the following plan. The Constitution lays out the infrastructure of the organization and covers the essentials: name, mission (if there is one), objectives, a statement on administration, memberships, and amendments to the above.

The By-Laws provide the working details of organization, administration, and membership in order to attain the objectives and manage the organization effectively. Provisions to amend the By-Laws should also be provided. In addition to the above, there should be a section on Procedures and Regulations (Policies). These details are in a category that can be changed or amended by the Board of Directors without the formalities of amendments to the By-Laws at a General Meeting.

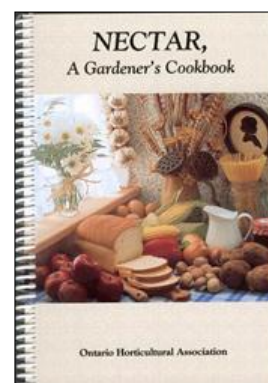
What is the difference between the new Directors' and Officers' Insurance and the insurance we have always had?

The new Directors' and Officers' Insurance, for which each society recently received an invoice of \$108.00, was instituted at the bidding of the general membership at the 2005 AGM. This insurance protects Officers and Directors in each Society, as well as the Officers and Directors of the OHA, in case they are sued while in performance of their duties. The D&O Insurance requires 100% participation from societies. General Liability Insurance, for which each society pays \$0.50 per society member, is quite different from D&O Insurance. This insurance protects the Society, its Directors and Officers, Members and Volunteers (while acting on behalf of the OHA or a member society), should they cause Bodily Injury or Property Damage to a Third Party. This is not an accident insurance policy, which is normally covered by a homeowner's property insurance.
